



Water's Edge, 2014 Pool Rules & Regulations

The following pool rules and regulations are designed to protect and benefit all owners/residents and guests at Water's Edge. Full enforcement by the pool lifeguard assures safe and healthy operation of pool facilities. Your cooperation in abiding by these rules is mandatory.

Hours & Days of Operation:

Memorial Day Weekend: The pool will open on **Saturday, May 24th** for the Memorial Day weekend (24th – 26th.) Hours of operation will be from 10:00 AM until 8:00 PM.

All Other Dates & Times:

Monday, Wednesday, Thursday	12:30 PM until 8:00 PM
Tuesday	Pool Closed
Friday, Weekends, Holidays	10:00 AM until 8:00 PM

The last day of the pool season will be **Monday, September 1st**. Hours of operation will be 10:00 AM to 8:00 PM.

At the discretion of the lifeguard or the management agent, the pool may be closed at any time due to mechanical failure, inclement weather or any other operational difficulties. The Board has requested that a notice advising of any such closure be posted at the front door explaining the circumstances.

Rules & Regulations

The following rules and regulations will also be posted at the pool. The lifeguards will be under strict instructions to abide by, and enforce, all rules and regulations.

- A. The lifeguard is responsible for enforcement of all pool rules and regulations. They have the absolute authority to suspend any person temporarily from use of the pool. Should such suspension occur, the lifeguard will file a written report – within 24 hours – with the Management Company. Additionally, the Board of Directors may suspend any offending owner's or resident's use of the pool for the season for any valid reason.
- B. Use of the pool is at your own risk. Water's Edge disclaims all responsibility. Water's Edge also holds no responsibility for the loss or damage to any personal property of pool users.
- C. Pool passes will be granted only to those owners who are in good standing. Should an owner fall behind in their assessments or other financial responsibilities to the Association, pool passes will be revoked immediately.
- D. All pool patrons must show a valid 2014 pool pass to gain access to the pool facility each visit, except as noted in Rule E. A maximum of four (4) passes will be issued per unit (guests will not require a pass, but must sign in.) No unit may have more than a total of eight (8) pool patrons at the facility at one time (to include children and guests – please see Rule E.) Any violation of the pool access rules will result in immediate suspension of pool privileges for the season.
- E. No pool passes will be issued to any child under the age of twelve (12). Each child under twelve (12) must be accompanied by a 2014 pool pass carrier, and be signed in upon entry to the facility.
- F. Elastic rubber infant pants must be worn at all times over disposable and/or other diapers when used in the pool.
- G. Usage logs will be posted at the lifeguard station. All those visiting the pool – owner, occupant or guest – are required to sign the log upon entry.
- H. Owners and residents are responsible for their actions as well as those of their guests. ***Parents will be held responsible for all actions of their children and their children's guests.*** The Management Company, on behalf of Water's Edge, can and will charge for the cost of any damage done to any community property.
- I. Safe behavior must be maintained at all times. No running, pushing, wrestling, or other undue disturbances will be permitted in the pool area. ***No abusive or profane language, unreasonable noise or breach of peace will be tolerated. After one warning the offending party may be prohibited from using the pool.***
- J. Use of the diving board is limited to one person at a time. No jumping or diving toward the pool walls is allowed. The lifeguard reserves the

right to close the diving board at his/her discretion and/or to prohibit any pool attendee from using the board if the attendee has violated any other pool rule.

- K. No pets shall be allowed in the pool areas **except for Service Animals**. However, under no circumstances shall any animal be in the water at any time.
- L. The use of rafts, life preservers, volleyballs and other play toys are allowed at the discretion of the lifeguard.
- M. Wheeled vehicles, such as skates, roller blades and skateboards are prohibited in the pool area.
- N. Anyone with apparent infections, diseases, sore or inflamed eyes, colds, nasal or ear discharges or any other communicable disease will be prohibited from entering the pool. Accordingly, anyone with excessive sunburn, open sores or bandages will also be barred from entering.
- O. No glass containers will be allowed in the pool area. Food may only be consumed on the wooden deck area. All trash must be placed in appropriate receptacles.
- P. Loud playing of music is prohibited. Should an attendee refuse to turn down the music, the lifeguard has the right to immediately expel the attendee.
- Q. All emergencies are to be managed by the lifeguard who will subsequently supply – within 24 hours – a written statement to the Management Company detailing the emergency.
- R. At the lifeguard's discretion, the last fifteen minutes of each hour will be dedicated to **adults-only lap swimming**. **No one under the age**

of 18 will be permitted to enter the pool at this time.

- S. The telephone at the pool is intended for the lifeguard to use in case of emergencies and/or to reach the Management Company. It will ***not be loaned to residents.***
- T. Please do not drive to the pool out of consideration to those residents who live in the pool laneway as parking can be scarce.
- U. Pool patrons reported in any violation of the rules may have their pool privileges suspended.
